COMMITTEE WEEKS

House committee weeks are an important part of the legislative process. During this time the committees meet to discuss the issues that they will be focusing on throughout the session. Here are a few of the things that were worked on in committee weeks this year:

In the last two months every council and committee has reviewed their areas of the budget to eliminate unnecessary spending and to try to make our government as efficient as possible. This work will help us as we prepare to make difficult budget decisions and balance Florida's budget.

The core missions of state agencies are being evaluated to ensure that their current operations comply with their original purpose. This is crucial, because if we want to be able to invest in what is important, we have to be willing to stop spending on what is not.

As a member of the House Governmental Affairs Policy Committee, I voted and helped to approve HJR 81, which would allow Florida voters to end public financing, or "welfare for politicians," in statewide political campaigns. Since 1998, taxpayers have paid over \$20 million to finance these campaigns.

2009 REGULAR SESSION

Our 2009 Legislative Session will be starting this Tuesday, March 3rd. During this up-and-coming session my committees are bringing many important issues to the table:

In the Agriculture and Natural Resources Policy Committee we have been asked to review the permitting process within various agencies and to look for ways to streamline the process and remove duplicative efforts by multiple agencies.

Within the Governmental Affairs policy Committee we are reviewing the Florida retirement system and looking for ways to eliminate problems within the system, including the abuse of the DROP Program.

In the State Universities and Private Colleges Committee we are considering a possible tuition increase within our state university system.

FCAT SCIENCE BILL- HB 543

House Bill 543, the Educational Assessment Bill, nicknamed the "FCAT Science Bill" will eliminate the mandatory 11th grade FCAT science test by the 2011-2012 school year and replace it with an end of course biology examination. The results of this test count towards the school's overall grade.

To replace the FCAT Science test, the Commissioner of Education will select a nationally developed biology test to be administered at the end of a regular high school biology course. Successful completion of this test will be required for graduation and students' scores will be factored into their comprehensive course grades.

THE CLASS SIZE RESOLUTION- HJR 919

House Joint Resolution 919, sponsored in the House by Rep. Will Weatherford, is a combined effort between the Florida House of Representatives and the Florida Senate. This resolution will give Florida voters the chance to change an amendment added to the Florida constitution in 2002 that limits class sizes in PreK-12th grade.

If passed, this resolution will switch the restrictions from a maximum number of students allowed per teacher to an average number of students allowed per teacher per school. By doing this, we will maintain a small average class size while saving the \$850,000 that would be needed to meet the strict perteacher maximums required by next year. Representative Mayfield is a cosponsor and supports this legislation.
