Our state is facing a broad-ranging and increasingly difficult set of economic challenges, but one goal is at the top of my legislative agenda this Session - finding a way to revitalize Florida's economy and help put Floridians back to work.

HELP FOR FLORIDA'S BUSINESSES

On March 2, 2010, in our first act of the 2010 Legislative Session, I voted in the House Chamber to support House Bill 7033. This legislation will help keep Floridians working and bring a degree of economic certainty to help create new jobs and foster economic growth in Florida. HB 7033 passed the House with a unanimous vote of 117 to 0.

This is a commonsense measure which will help to hold down dramatic increases in unemployment tax rates for employers for the next two years. Prior to the passage of this legislation, many employers were expected to see rate increases of over 1000%.

This legislation was passed by the Senate and the measure was signed into law by Governor Charlie Crist later that day.

WELL DONE AT INDIAN RIVER COUNTY CHAMBER

HIGH PERFORMANCE GOVERNMENT

Speaker Larry Cretul stated in his opening day remarks that "Floridians do not want a government that tries to do all things for all people. They want a government that focuses on the important things, and does them well.



They want a focused, high performance government." To ensure that this initiative is carried out during this legislative session, the Speaker has outlined an agenda. Each week I will be discussing portions of this agenda with each of you.

State Budget Made Responsible: We must ensure that there is transparency of the budget process by publically disclosing allocations, providing plain-language explanatory comments on budget spreadsheets, publishing a separate spreadsheet highlighting all new budget proviso, and requiring a public process for budget proviso during the conference process.

CONSTITUTIONAL OFFICERS

House Bill 417, of which I am a cosponsor, seeks to amend s. 447.203, which defines who is a "legislative body" in collective bargaining for the purpose of resolving impasses. Section 447.403 only relates to the resolution of impasses between a collective bargaining unit and a public employer.

More importantly, this bill preserves the independence of locally elected constitutional officers (Sheriff, Clerk of Court, Supervisor of Election and Tax Collector) and allows them to retain the management authority they need to carry out their responsibilities while remaining accountable to the electorate.

This legislation is currently in the Governmental Affairs Committee. I look forward to debating this issue and will continue my steadfast support.
