STANDARD & POOR'S OUTLOOK ON FLORIDA UPDATED

Standard & Poor's Publication date: July 12, 2011

Standard and Poor's Ratings Services has revised its outlook on the state of Florida to stable from negative. Standard & Poor's also assigned its AAA long-term rating to Florida's State Board of Education, Public Education Capital Outlay (PECO) series 2011C refunding bonds.

The AAA rating reflects significant progress in restoring structural budget balance in response to changes in economic growth trends, the phase out of American Recovery and Reinvestment Act stimulus funding, service based economy that continues to depend on tourism and in-migration and continues to be dragged down by the severely weakened housing market and good income levels.

The outlook revision reflects Standard and Poor's view of the state's improved revenue environment and a fiscal 2012 budget that is structurally balanced and improves reserve funding levels.

SEBASTIAN SATELLITE OFFICE



Throughout this year's Legislative Session, our budet decisions and bills were viewed through the lens of our goal to get Florida's economy back on track and helping to get Floridians back to work. To that end this past session the Legislature voted to make projobs modifications to our Unemployment Compensa-

tion System by providing tax relief to Florida's job creators, adjusting benefits to match Florida's economic circumstances, and clarifying workplace expectations for employers and employees.

On Monday and Tuesday of this week I had the pleasure of visiting Brevard Workforce and St. Lucie County Workforce Solutions to get a first hand look at how this legislation is being implemented and how well it is working. I was particularly interested in seeing how the new legislation helps re-employ a claimant by providing an initial skills review following unemployment benefit eligibility determination. I plan to stay actively engaged in this process and monitor the unemployment situation in District 80.
