### What is a Pill Mill?

A "Pill Mill" is defined as any doctor's office, clinic, or health care facility that routinely conspires in the prescribing and dispensing of controlled substances outside the scope of the prevailing standards of medical practices in the community.

Florida has lead the nation in diverted prescription drugs, resulting in seven Floridians dying every day. The proliferation of pill mills contributes to Florida being the destination for distributors and abusers.

#### Common characteristics of a Pill Mill include:

- Cash only/No insurance
- No appointments
- Armed guards
- Little to no medical records
- Grossly inadequate physical exams
- Large prescription doses of narcotics, exceeding boundaries of acceptable medical care

## FLORIDA'S PILL MILL INITIATIVE

The Florida Legislature has worked with Attorney General Pam Bondi to take a hard line approach to the illegal prescription drug abuse trade. With the passage of [HB7095](#), Florida bans dispensing of certain controlled substances by practitioners, limits the dispensing of these prescription drugs to certain kinds of pharmacies, and promotes a stringent minimum standard of care. Since the passage of this bill in 2011, the DEA now ranks Florida as housing 13 of the top 100 oxycodone purchasing physicians in America, down from 90 the year prior. For over two years, the State of Florida and Attorney General Pam Bondi has worked diligently in conjunction with the Federal DEA authorities in investigating and prosecuting the perpetrators of the prescription drug abuse that has characterized much of the state. The statewide Pill Mill Initiative ensures that the issue is adequately addressed by all branches of government.

## OPERATION: PILL STREET BLUES

I want to extend my congratulations on a job well done to our state and local law enforcement entities, especially to the Indian River County Sheriff's Office led by Sheriff Deryl Loar, for their collaborative efforts and their dedication to bringing pill mills to justice. I am happy to report that much of those efforts culminated in the successful bust of several pain management clinics ("pill mills") around the state, including Stuart Pain Management Clinic in Vero Beach. Through a series of inspections, which included undercover visits to clinics and interception of phone conversations between offending parties, a total of 14 defendants were arrested, 59 bank accounts totaling \$1.1 million were seized, and 13 search warrants have been executed around the state. The prosecution will take place in the State Attorney's Office 19th Judicial Circuit by the Attorney General's Office of Statewide Prosecution.

While the investigations have been helpful in bringing forward necessary evidence for an arrest, they also provide the general public with information about the operations of these seedy businesses. Far from generating patient care, these clinics make money from promoting direct harm to patient health and the community at large. Many continued to prescribe high levels of pain pills despite patients showing no trace of it in their drug screens. In one case, a particular "patient" reported being told by another doctor that he was addicted to oxycodone, and the offending doctor went on to prescribe him even more oxycodone instead of drug treatment. These are just some of the red flags a person needs to consider when seeking pain management advice. Please report any suspected abuses to your local law enforcement agencies.
