SALES TAX HOLIDAY BEGINS THIS FRIDAY

The 2012 Florida Legislature passed and the Governor approved a tax-free period that begins **Friday, August 3rd** at 12:01AM and runs through **Sunday night, August 5th** at 11:59PM. Clothing, footwear, and accessories under \$75, and school supplies under \$15, will be sales-tax free. Additionally, many retailers plan sales around this event. GREAT FLORIDA TREASURE HUNT



If you have ever lived in Florida, there is a chance that the state is holding unclaimed property for you. Currently, the Department of Financial Services holds unclaimed property valued at more than \$1 Billion. These unclaimed accounts come mostly from:

Dormant Accounts in:

- Financial Institutions
- Insurance & Utility Companies
- Securities & Trust Holdings

Tangible Property, such as:

- Jewelry
- Coins & Currency
- Stamps & Other Historical Items

Any unclaimed money is deposited into the state school fund and used for public education. However, citizens have the right to claim their property at any time at no cost, and there is no statute of limitations. Or, you may call the Florida Department of Financial Services at **1-888-258-2253** and request to be mailed a claim form.
