#### CHOICES FOR INSURANCE COVERAGE

The Florida Office of Insurance Regulation offers an interactive program, named CHOICES, to Florida residents who are shopping for automobile and/or homeowners insurance. CHOICES is a program that it is designed to give consumers the ability to compare automobile and/or homeowners insurance rates using sample risk scenarios created for each. Using these sample rates helps you to ensure that you are receiving the best value and coverage.

Under the direction of Florida's Insurance Commissioner, Kevin M. McCarty, two new online video tutorials have been added to the website to assist consumers in learning about the system. There is a tutorial available for both automobile and homeowners insurance options, and each of them provide step-by-step voice instructions on how to access and maneuver through the CHOICES system. They also provide essential information on the breakdown of statewide rates by county, the various risk scenarios consumers can choose from, and a brief description on the components within insurance policies. #### FLORIDA'S DEBT REDUCTION

At a recent meeting of the Florida Cabinet, the Division of Bond Finance, an arm of the State Board of Administration in charge of issuing bonds for or on behalf of the State, reported that Florida has reduced its outstanding debt by \$2 Billion over the last two years. The Director of the Division of Bond Finance, Ben Watkins, also reported that ongoing debt refinancing has saved taxpayers an additional \$744 million on future interest payments in the same time period. Refinancing our outstanding debt to lower interest rates is a great example of how fiscal discipline helps keep money in the pockets of hardworking Floridians.

The State of Florida has made tough decisions during these tight economic times. The Division of Bond Finance has done a great job in helping to cultivate an attractive, stable business environment by doing what is necessary to preserve our AAA credit rating. I commend Director Watkins for his diligent efforts and commitment to creating a more prosperous Florida by striving for limited government.

#### EDUCATION AGENDA

Recently, Governor Scott announced his education agenda for the 2013 legislative session. Entitled "College and Career FIRST" (Focusing Investments on Results for Students and Teachers), the agenda was created based on feedback he gathered during a month-long education listening tour, where parents, teachers, students, superintendents and union representatives were incorporated in a discussion on how to better prepare students for college and careers.

Governor Scott has committed to protecting current education funding levels in this year's budget, but aims to provide a clearer focus on where the funding levels (or, "investments") are directed. In essence, the money needs to follow good policies that provide real and positive results to both students and teachers.

The three overarching goals of the Governor's education agenda are: Accountability in Transition, Support Teachers, and Flexibility in Education.
