Enrolled Bill

Once a bill has passed both chambers, it is enrolled in the house of origin under the supervision of the Clerk of the House or the Secretary of the Senate. After it has been enrolled and signed by officers of both houses, it is then sent to the Governor for action and transmittal to the Secretary of State. The version of the bill sent to the Governor is referred to as an enrolled bill.

Law

Once a bill is enrolled and sent to the Governor, the Governor has three options:

- Approve the bill by signing it into law;
- Allow the bill to become law without a signature; or
- Veto the bill. A veto may be overridden by a 2/3 vote by the House and Senate.

Once the bill is approved by the Governor, allowed to become law without a signature, or the Governor's veto is overridden by the Legislature, the bill becomes law.

IMPORTANT LEGISLATION SIGNED BY THE GOVERNOR

HB7027—Unemployment Compensation: Renames the state's "unemployment compensation" system to a "reemployment assistance" program that offers free job skills training to applicants who score poorly on a skills test. The measure also decreases the amount of the unemployment compensation tax increase on businesses this year and gives businesses an extra two years to pay off federal loans. Businesses will save \$800 million because of that measure. The law takes effect July 1.

HB 7029 – Nullification and Repeal of Administrative rules: Eliminates 270 obsolete regulations and allows for a more streamlined process for the Department of State to strike outdated regulations. The law takes effect May 25.

HB 7087 – Economic Development: Provides \$120 million in tax breaks to businesses. The tax cuts include an increase in the corporate income tax exemption from \$25,000 to \$50,000. The bill lowers taxes on pumping from mature oil fields and increases sales tax exemptions on electricity in packinghouses, aircraft weighing more than 2,000 pounds, and parts and chemicals used to make aircraft and gas turbines. A three-day back-to-school sales tax holiday is also included which will take place August 3rd thru 5th 2012. The law takes effect July 1.
